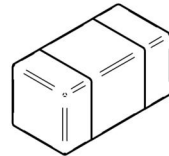

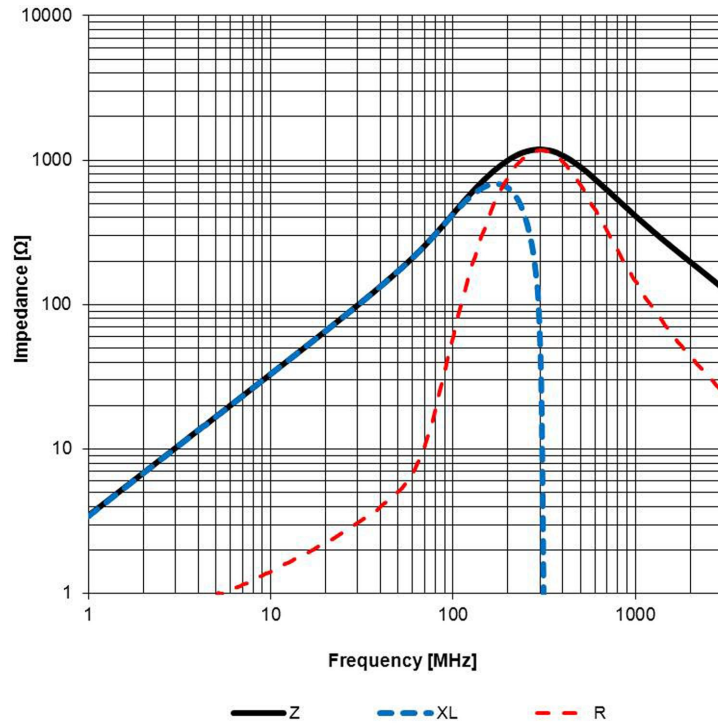

- All products shall be used before the end of the period of 12 months based on th product date-code, if not a 100% solderability can't be warranted.
