




Power Consumption

Dimensional Drawing ³⁾

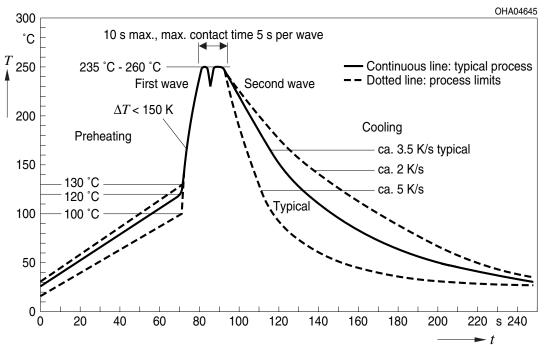
