The Transient Voltage Suppressor series offers a choice of Working Peak Reverse Voltage from 12 V up to 170 V and Breakdown Voltage up to 209 V. Typical fast response times are less than 1.0 ps from 0 V to Breakdown Voltage.

Bourns® Chip Diodes conform to JEDEC standards, are easy to handle with standard pick and place equipment and the flat configuration minimizes roll away.


#### **Rating & Characteristic Curves**




**Pulse Waveform** 









Maximum Non-Repetitive Surge Current




