# Q-Factor vs. Frequency:




# **Typical Temperature Rise vs. Current Characteristics:**

  be ensured.
- Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
- Due to heavy weight of the component, strong forces and high accelerations might have the effect to damage the electrical connection
  or to harm the circuit board and will void the warranty.
